

Billing Details and Good Faith Estimates for the Patient

CPTE Senior Therapy Services specializes in providing rehabilitation care to a Senior population. We make sure that Seniors continue to receive the quality healthcare they are entitled to. We are proud to be a Medicare certified provider and, as we explain below, this protects you, the patient from unexpected charges.

CPTE Senior Therapy Services accepts Medicare assignment. **This means that CPTE Senior Therapy Services accepts Medicare's allowed amounts for services as full payment. A Good Faith Estimate for an average treatment is \$95.00.** Medicare pays 80% of their allowed amount (after the yearly deductible) and you are responsible for the remaining 20% (as well as the yearly deductible). **A Good Faith Estimate for your portion of an average treatment is \$19.00.**

Supplemental insurance may pay some portion of your balance. CPTE Senior Therapy Services will bill any supplemental insurance. Please understand that your supplemental insurance may have limitations or restrictions that may reduce coverage, including CPTE Senior Therapy Services being an out-of-network provider. **It is your responsibility to know those limitations as they may increase the balance owed for services. In such circumstances, a Good Faith Estimate for your portion of an average treatment is \$19.00**

Patients will usually have a remaining balance, even after Medicare and supplemental plans have processed the charges, **CPTE Senior Therapy Services requires a credit/debit card placed on file in order to pay for any remaining balances. Rest assured that you will receive a statement clearly explaining any charges made to your account.**

Some patients participate in a Medicare Advantage Plan or other commercial plans. CPTE Senior Therapy Services is happy to bill those insurances but you, the patient, must understand that you will be charged for any patient balances that accumulate. **These plans usually come with visit limitations, pre-authorization requirements, deductibles, co-insurances and/or co-pays and it is your responsibility to confirm the cost-sharing of their particular plan.**

Additionally, CPTE Senior Therapy Services may not be a participant in some network plans. It is your responsibility to confirm these limitations as well. If CPTE Senior Therapy Services is an out-of-network provider for your plan, CPTE Senior Therapy Services will only charge you, the patient, the approximate amount that traditional Medicare would allow. A Good Faith Estimate for an average treatment is \$95.00
